GENERAL TERMS

- I (the artist) reserve the right to refuse service for any reason without providing justification.
- I retain all rights to the commissioned art including the right of selling prints and using it in advertisement, books, banners, portfolios, etc.
- Any alterations made to the commissioned art such as but not limited to the removal of signature and recoloring are prohibited, unless written permission is given by me.
- You (the client) are allowed to use the commissioned art for non-commercial purposes under the Creative Commons Attribution-NonCommercial-NoDerivs (CC BY-NC-ND) license.
- Should you decide to post the commissioned art online, proper credit must be given to me, under the name "ARCR-CRic", you may also provide a link to my website or social media accounts.
- For an additional fee, you will be granted commercial rights to the commissioned art including the rights to make alterations.
- I reserve the right to share works in progress of the commissioned art with whom I see fit as well as to share it in services such as Patreon or similar.
- Should you wish to have the commissioned art as well as its creation process kept private, an additional fee may apply.

EDIIS

- Edits to the commissioned art after the sketching stage or after the commission is finished may incur in additional fees.
- I reserve the right to refuse edits if I deem that they are not possible to execute due to limitations of the media in case of traditional art pieces or due to the amount of effort required for it.

RESULTS & SHIPPING

- Once the commission is finished, you will receive both high and low resolution digital copies of the art as well as any variants if applicable.

CANCELLATIONS & REFUNDS
